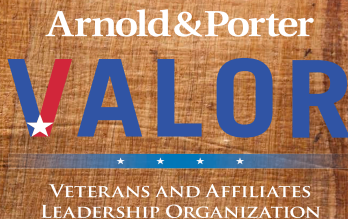

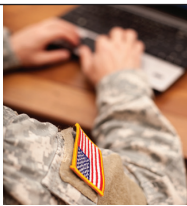

EXECUTIVE DIRECTOR'S WELCOME



Welcome to our Awardees, Veterans and their loved ones, members of our TVC National Volunteer CorpsSM, members of Congress and the Judicial and Executive Branches, Distinguished Guests, Mission Partners, and Supporters. Tonight, on this special evening, we pause to recognize the work of so many people making a real difference in the lives of Veterans and their families, caregivers, and survivors. Over the past 26 years, our TVC National Volunteer Corps, Mission Partners, and dedicated staff have handled more than 47,000 Veterans' requests for legal assistance, trained over 4,300 attorneys and paralegals from law firms and corporate legal departments, helped law schools build veterans law programs or legal clinics, and prevailed in more than 80% of our federal cases. These achievements translate into over \$110 million in pro bono legal services for Veterans, and by our calculations more than three times that when we add the lifetime value of care, benefits, and disability compensation that have changed our clients' lives.

Stretching from coast to coast, our TVC National Volunteer Corps has successfully represented cases from all 50 States, the District of Columbia, and all U.S. Territories (plus many countries where U.S. Veterans live abroad). As the leading national charitable organization providing pro bono legal services for Veterans in federal venues, our volunteers come from organizations as diverse as large corporate legal departments and small academic veterans law clinics, from a majority of the Am Law 200 firms to newly-minted solo practitioners. As varied as these backgrounds may be, these many volunteers joined forces as part of The Veterans Consortium because we all share a passion to provide equal access to justice for our Veterans before the U.S. Court of Appeals for Veterans Claims, the Federal Circuit, and the U.S. Supreme Court.

We gather tonight to honor awardees who have gone above and beyond the call of duty, to provide the best legal services free of charge to help Veterans and their loved ones meet their challenges. These awards are representative of the hard work and dedication of so many other organizations and individuals—we truly wish we could recognize each and every one of them tonight.

While these remarkable accomplishments are truly worthy of celebration, we have so much more to do. U.S COURT OF APPEALS FOR VETERANS CLAIMS

The United States Court of Appeals for Veterans Claims is a federal court of record established by Congress through the Veterans' Judicial Review Act (VJRA), which was signed into law on November 18, 1988 (now codified in chapter 72 of title 38, United States Code). Prior to the VJRA, veterans who were denied claims for VA benefits, or who disagreed with findings of the Board of Veterans' Appeals (Board), had no right to pursue any review of Board decisions. The Court provides this independent judicial review and is not part of the Department of Veterans Affairs. The Court has exclusive jurisdiction to review final Board decisions based on the record before the agency and arguments of the parties, which are presented in a written brief, with oral argument generally held only in cases presenting new legal issues. The Court's principal office is in Washington, D.C., but the Court is authorized to sit anywhere in the United States and does so a limited number of times each year, typically at law schools across the nation as part of an educational outreach program. The Court is authorized seven permanent, active Judges, and two additional Judges as part of a temporary expansion provision. Judges generally are appointed for 15-year terms, and each Judge has the option upon retirement to agree to be available for further service as a recall-eligible Senior Judge. During any period of recall service, a Senior Judge has all of the judicial authority and powers of a Judge in active service.


PRO BONO PROGRAM FOR VETERANS

At the request of the Court's founding Chief Judge, Frank Q. Nebeker, the Federal Pro Bono Program for Veterans was created by the U.S. Congress in Public Law No. 102-229 and marked its 25-year milestone in 2017. The law provides for the "...furnishing of legal and other assistance, without charge, to veterans and other persons who are unable to afford the cost of legal representation in connection with decisions to which section 7252(a) of title 38, United States Code, may apply, or with other proceedings in the Court, through a program that furnishes case screening and referral, training and education for attorney and related personnel, and encouragement and facilitation of pro bono representation by members of the bar and law school clinical and other appropriate programs, such as veterans service organizations, and through defraying expenses incurred in providing representation to such persons. Provided, That such grants or contracts shall be made by the Legal Services Corporation pursuant to a reimbursable payment from the United States Court of Veterans Appeals...." [now the U.S. Court of Appeals for Veterans Claims].



Legal Services Corporation

LSC is the single largest funder of civil legal aid for low-income Americans in the nation. Established in 1974, LSC operates as an independent 501(c)(3) nonprofit corporation that promotes equal access to justice and provides grants for high-quality civil legal assistance to low-income Americans. LSC distributes more than 93% of its funding to 133 independent nonprofit legal aid programs with more than 800 offices. LSC promotes equal access to justice by awarding grants to legal services providers through a competitive grants process; conducting compliance reviews and program visits to oversee program quality and compliance with statutory and regulatory requirements as well as restrictions that accompany LSC funding, and by providing training and technical assistance to programs. LSC encourages programs to leverage limited resources by partnering and collaborating with other funders of civil legal aid, including state and local governments, Interest on Lawyers' Trust Accounts (IOLTA), access to justice commissions, the private bar, philanthropic foundations, and the business community. LSC is headed by a bipartisan board of directors whose 11 members are appointed by the President and confirmed by the Senate.

- ★ Provide pro bono legal services for men and women who served but received "Other Than Honorable" (OTH) Discharges, (an OTH precludes eligibility for care, benefits, and compensation), and were unreasonably denied veteran status:
 - This is an opportunity to focus on cases involving Post-Traumatic Stress Disorder (PTSD), Traumatic Brain Injury (TBI) cases, or other mental health conditions; and,
 - Help clients appeal to a military service's Discharge Review Board (DRB) or a Board for Correction of Military Records (BCMR).

- ★ Serve veterans directly at our National Veterans & Appellate Law ClinicSM

Serve for a half-day at this weekly pro bono legal information/referral clinic at the VA Medical Center in Washington, DC, staffed by volunteer attorneys and law students from TVC's National Volunteer CorpsSM in partnership with NLSP-DC and the VA.
 - Annually: Celebrate DC Pro Bono Week 2018, by joining us for the third annual TVC Legal MusterSM to provide legal information, referrals, and resources for underserved veterans in the Nation's Capital. The annual TVC Legal MusterSM was created to enhance wrap-around care for veterans who are often unaware of available resources. TVC National Volunteer CorpsSM members will triage legal matters for veterans on 26 October 2018 at the DC VA Medical Center, Neighborhood Legal Service Program-DC Offices, and at Easterseals/Steven A. Cohen Military Family Clinic in Silver Spring, MD.

The Honorable Tammy Duckworth
United States Senator
U.S. Veteran

U.S. Senator Tammy Duckworth is an Iraq War Veteran, Purple Heart recipient and former Assistant Secretary of the Department of Veterans Affairs. She was among the first Army women to fly combat missions during Operation Iraqi Freedom.

Duckworth served in the Reserve Forces for 23 years before retiring from military service in 2014 at the rank of Lieutenant Colonel. She was elected to the U.S. Senate in 2016 after representing Illinois's Eighth Congressional District in the U.S. House of Representatives for two terms.

Duckworth attended college at the University of Hawaii and earned a Master of Arts in International Affairs from the George Washington University. Following graduation, Duckworth, who is fluent in Thai and Indonesian, moved to Illinois and began pursuing a Ph.D. in Political Science at Northern Illinois University.

In 2004, Duckworth was deployed to Iraq as a Blackhawk helicopter pilot for the Illinois Army National Guard. On November 12, 2004, her helicopter was hit by an RPG and Duckworth lost her legs and partial use of her right arm. Following her recovery, she became Director of the Illinois Department of Veterans Affairs, working to create a tax credit for employers who hired Veterans, establish a first-in-the-nation 24/7 Veterans crisis hotline and develop innovative programs to improve Veterans' access to housing and health care.

In 2009, President Obama appointed Duckworth to be Assistant Secretary of Veterans Affairs. At VA, Duckworth coordinated the joint initiative with the U.S. Department of Housing and Urban Development to end Veteran homelessness. She also created the Office of Online Communications to improve the VA's accessibility, especially among young Veterans, and also worked to address the unique challenges that Native American and female Veterans face.

In the U.S. Senate, Duckworth serves on several influential committees that give her an important platform to advocate for Illinois's working families and entrepreneurs: the Environment & Public Works Committee; the Energy & Natural Resources Committee; the Commerce, Science, & Transportation Committee; and the Small Business & Entrepreneurship Committee. As Senator, she advocates for practical, common-sense solutions needed to move our country and our state forward like: rebuilding our crumbling infrastructure, keeping our water systems safe and lead-free, growing manufacturing jobs while supporting minority-owned small businesses, investing in communities that have been ignored for too long, and making college more affordable for all Americans. And Duckworth continues with her lifelong mission of supporting, protecting and keeping the promises we've made to our Veterans as well as ensuring that we stand fully behind the troops we send into danger overseas.

Steve Parker

Steve Parker is President at WorkMerk, a privately-held education technology company that specializes in custom training solutions for individuals, businesses, VSOs and government agencies who consume continuing education, value employee/member engagement and advanced skills. Steve is charged with accelerating customer outcomes, growing WorkMerk partnerships, and mapping detailed customer experience

data, in order to understand, align and adjust to the needs of the workforce.

Steve recently led an innovative, custom-design, delivery and assessment program of military education to more than 40 institutions across 25 countries in Africa, in partnership with the U.S. State Department.

As Executive Director of Joining Forces, he worked closely with First Lady Michelle Obama and Dr. Jill Biden to improve educational, wellness and employment outcomes for veterans and military families. As a White House Fellow, Steve worked for First Lady Laura Bush on Helping America's Youth, a Presidential initiative aimed at improving educational and social outcomes for at-risk youth during the Bush 43 administration.

A retired Army Colonel with a proven record of excellence in command, operational planning and training in federal interagency and international environments. He led a formation of more than 1,000 troops during 13 months of combat operations in Iraq. Steve later served as the Chief of Operations, Training and Digital Simulations for the US Army's premiere training delivery and deployment platform for Artillery, Air Defense and Electronic Warfare; where nearly 50,000 Soldiers, Marines and Allied military students from 52 countries train annually.

Steve is a graduate of The United States Military Academy, where he earned his B.S. in National Security Studies. He received his M.A. in African Studies at Yale University.

Adria Horn graduated from the United States Military Academy at West Point, New York in 2001. She was commissioned as a Second Lieutenant in the United States Army Military Police Corps and served in various positions as both a Military Police Officer and a Psychological Operations Officer. She deployed five times in support of the Global War on Terror. In 2011, she separated from Active Duty and moved to Maine.

Adria is a Lieutenant Colonel and Individual Reservist in the United States Army Reserve and currently serves as a Future Operations Planner for the United States Pacific Command. She holds an MBA from Northeastern University. Previously, she worked for U.S. Senator Susan Collins. Appointed by Maine Governor, Paul LePage, in April 2015 she served as the Director of the Maine Bureau of Veterans' Services until September 2018 at which time she transitioned to the private sector as VP of Workforce Development for Tilson Technology Management out of Portland, Maine.

Colleen is a commercial litigator who primarily represents financial institutions in federal and state court actions concerning breach of contract, property disputes and title issues. Colleen also has experience representing insurance companies concerning coverage analyses and the litigation of personal, commercial, and professional liability policies.

Colleen initiated a firm-wide partnership with The Veterans Consortium Pro Bono Program. As the team leader for this partnership, Colleen helped organize and publicize a Veterans Consortium training which Quarles & Brady hosted in August 2017 at its Milwaukee office with live video feed across eight other Quarles' offices. The following year in February of 2018, Colleen organized a second training, which Quarles hosted at the Chester Ferguson Law Center in Tampa, Florida, and which was open to the Tampa Bay legal community. As a result of the two trainings, over one hundred and sixty attorneys learned how to represent veterans in their appeals for disability benefits.

Colleen continues to represent veterans before the U.S. Court of Appeals for Veteran Claims and help them with their discharge upgrade petitions. Colleen has continued to spread the word, presenting to in-house counsel for several large corporations and firm clients about opportunities to partner on veteran disability appeals. Her motto is: "Let's get together and help a veteran in need." For her dedicated advocacy for veterans, Colleen has been recognized by the Veterans Consortium Pro Bono Program as a Volunteer Inspiring Pro Bono (VIP).

Colleen graduated from the University of Miami School of Law School magna cum laude in 2007. While attending the University of Miami, she was awarded the Dean's Certificate of Achievement Award for Constitutional Law, Evidence, Criminal Law, and a CALI Award of Excellence for Insurance Law and Policy. Prior to attending law school, Colleen graduated from Texas Christian University summa cum laude with a Bachelor of Arts in Biology, and a Bachelor of Science in Criminal Justice.

This was a hard-earned victory for appellant Marcus D. Garrett, a Vietnam veteran seeking justice and access to the care, benefits, and compensation he earned while serving his country in combat. Ms. Donegan is a seasoned attorney whose 25-year legal career includes more than a decade representing U.S. Military veterans before the CAVC and the Department of Veterans Affairs. She has led or participated in more than 2,000 federal appellate cases before the CAVC.
